Unless otherwise contained in Schedule B or C, below, the tax on all trades, occupations, professions, businesses and franchises within the Town shall be based on gross sales/receipts as reported on the trades, occupations, professions, businesses and franchises North Carolina State Income Tax Return or square footage, whichever is greater in the following amounts:

Schedule B

All trades, occupations, professions, businesses and franchises for which city license taxes are restricted or limited pursuant to Schedule B of the Revenue Act, as amended, shall be taxed at the maximum amount allowed by state law. For this purpose, the definitions and maximum tax amounts permitted cities as set forth in Schedule B of the Revenue Act, are hereby adopted and incorporated herein by reference, including but not limited to the following. This fire may generally be started between 9 a.m. and 3 p.m. and no combustible material may be added to the fire between 3 p.m and the end of the workday.
